Following non from last night's full council meeting, no new objections were raised on the below application.

Graig Quarry, Graig Road, Denbigh  
Consolidating application for the extension of winning and working of limestone, importation of inert waste and restoration to amenity land.

The town councillors had no additional objections to those listed in July 2022.  
Objections were raised on the following grounds:

Environmental issues to include health and wellbeing, damage to properties, dust pollution, noise pollution, loss of green spaces, loss of public space for recreational purposes,

Traffic – more traffic at an already busy road. High impact on local residents.

No benefit to Denbigh residents.

There is no need for the product from the quarry in Denbighshire.

The town councillors would also like it noted that if the plans do not come to fruition and in time the quarry closes that the current employees are offered work at an alternative location and not made redundant.
